MEMORANDUM OF DECISION

Defendant Dale McAvey appeals from a judgment of the Superior Court (Penobscot County, *Mead, J.*) dismissing defendant's appeal of judgments entered in the District Court (Bangor, *Stitham, J.*) finding him guilty of refusing to sign uniform summons and complaint (Class E), 29-A M.R.S.A. § 2601(10) (Supp. 1999), failure to give correct name and address to officer (Class E), 29-A M.R.S.A. § 105 (Supp. 1999), and operating after revocation (Class D), 29-A M.R.S.A. § 2557 (Supp. 1999). Because defendant failed to provide a transcript of the trial court proceedings, we are unable to review the merits of his arguments. *See State v. Ross*, 1997 ME 67, ¶ 1, 691 A.2d 1253, 1254.
