### MEMORANDUM OF DECISION

The mother appeals from the judgment of the District Court (Bangor, *Gunther, J.*) terminating her parental rights to Scott, Brandon, and Anastasia. The evidence of, inter alia, the mother's lack of cooperation with counseling for her psychological problems and substance abuse issues and her continued relationships with men who use illegal drugs, was sufficient for the court's finding that she failed to make good faith efforts to rehabilitate and reunify with the children, 22 M.R.S.A. § 4055(1)(B)(2)(b)(iv) (1992), and that termination was in the best interest of the children, *id.* § 4055(1)(B)(2)(a). The court's factual findings, although not as detailed as they could have been, were sufficient to inform the parties and this Court of the reasons for its decision. *See In re David G.*, 659 A.2d 859, 862 (Me. 1995).
